

JSW posts 66% growth in Crude steel production for January, 2010

JSW Steel Limited reported a growth of 66% in Crude Steel production for January 2010 compared to that of corresponding month in the last fiscal year.

The break-up of production is as below:

The company achieved 4.92 million tons of Crude steel production cumulatively upto January 2010 in the current fiscal year showing growth of 60% over corresponding period of the last year.
