

**JSW Steel posts 33% growth in Crude Steel production – May 2009**

JSW Steel Limited reported a growth of 33% in Crude Steel production for May 2009 compared to that of corresponding month in the last fiscal year. The substantial growth in production is mainly attributable to the production from 2.8 MTPA expansion project at Vijayanagar works.

The break-up of production is as below:
