

JSW Steel posts 3% growth in Crude Steel production – August 2010

JSW Steel Limited reported a growth of 3% in Crude Steel production for August 2010 compared to that of corresponding month in the last fiscal year. The Company also reported 4% growth in monthly Crude Steel production sequentially.
