

MANAGEMENT'S RESPONSIBILITY:

- 1. The Management of the Company is responsible to ensure compliance with the requirements of the Companies Act, 2013 and the Rules made thereunder; including MCA Circulars issued by MCA, the SEBI Circulars; and Listing Regulations pertaining to postal ballot / e-voting conducted through electronic means on the resolution contained in the Notice.
- 2. The Board of Directors has authorised Ms. Monica Chopra, Company Secretary and Compliance officer of the Company to ensure the conduct of Postal Ballot process.

CUT-OFF DATE:

- 3. Pursuant to the MCA Circulars, the Members of the Company holding Equity Shares as on Friday, 28th July, 2023, being the cut-off date were entitled to vote on the proposed Resolution as set out in the Notice through e-voting only.
- 4. Pursuant to the provisions of the Act and MCA Circulars, the Company has sent Notice to its Members whose name appeared in the Register of Members / List of Beneficial Owners as received from National Securities Depository Limited / Central Depository Services (India) Limited as on the cut-off date i.e., 28th July, 2023 and whose e-mail IDs were available with the Company / RTA / Depositories, through electronic means only. In accordance with the MCA Circulars, no physical copy of the Notice, postal ballot form and pre-paid business reply envelope was dispatched to the Members. Also, the Company was not required to provide the facility of voting through physical postal ballot. Therefore, the voting done through e-voting only was considered for this report.

REMOTE E-VOTING:

- **5.** The Company has engaged services of KFin Technologies Limited ('KFin') as the Agency for providing the facility of remote e-voting to the Members of the Company.
- 6. The remote e-voting period commenced on Wednesday, 2nd August, 2023 at 9:00 a.m. I.S.T. and concluded on Thursday, 31st August, 2023 at 5:00 p.m. I.S.T. on KFin's e-voting platform.

SCRUTINIZER'S RESPONSIBILITY:

7. My responsibility as a scrutinizer is restricted to make Scrutinizer's report of the total votes cast in "favour" and "against" including the details of invalid votes, if any, on the resolution stated in the Notice.

ADVERTISEMENT:

- 8. As stated in sub-rule 3 of Rule 22 of the Companies (Management and Administration) Rules, 2014 as amended from time-to-time, public notices were published by the Company in Financial Express ('English Language') and in Navshakti ('Marathi Newspaper') on 2nd August, 2023 informing about the completion of dispatch of notices to its Members through electronic means.
- 9. I monitored the process of electronic voting (i.e. remote e-voting) through the scrutinizer's secured link provided by KFin through its designated platform.
- **10.** After completion of e-voting, votes cast by the Members, were unblocked by me in the presence of two witnesses, Mr. Vishal Yadav and Ms. Nayab Musa who are not in the employment of the Company.
