**Crude Steel production at 2.86 Million Tons for Q1 2013-14**

Following the effectiveness of Composite Scheme of Amalgamation and Arrangement from 01/06/2013, JSW Steel Limited reports quarterly Crude Steel production at 2.86 million tons for Q1 FY 2013-14 at its three manufacturing locations viz. Vijayanagar, Salem and Dolvi all together.
